

**OFFICIAL SUMMARY PROCEEDINGS OF THE BOARD OF  
COUNTY COMMISSIONERS, TETON COUNTY, WYOMING**

The Teton County Board of Commissioners met in regular meeting on **September 19, 2022** in the Commissioners Chambers located at 200 S. Willow in Jackson. The meeting was called to order at 9:04 a.m.

Commission present: Natalia Macker, Chairwoman, Luther Propst, Vice-Chairman, Mark Barron, and Mark Newcomb were present. Greg Epstein was absent.

**ADOPT AGENDA**

A motion was made by Commissioner Barron and seconded by Commissioner Propst to adopt the agenda as presented. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

**PUBLIC COMMENT**

Public comment was given by Brady Hansen regarding the acquisition a new Fire Marshal to replace Cathy Clay. Public comment was given by Chris Neubecker regarding the acquisition of a new Code Compliance Officer, William Hutt. Public comment was given by Mike Rooks regarding permitting requirements for fire safety.

**ACTION ITEMS**

1. Consideration of Payment of County Vouchers

A motion was made by Commissioner Newcomb and seconded by Commissioner Barron to approve the September 19, 2022 county voucher run in the amount of \$ 1,261,494.84. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

  - a. 24-Hour Liquor Permits

A request for approval of a 24-hour Catering Permit.

A motion was made by Commissioner Propst and seconded by Commissioner Barron to approve the 24-hour catering permit submitted by Bar-SIP-Bar, LLC / The Liquor Store for a wedding reception to take place at the Diamond Cross Ranch, 24340 N Diamond Cross Road, Jackson, WY on October 1, 2022 with the permit being valid for a 24-hour period. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

A request to authorize signature on Human Service/Community Development Contracts for services approved by the Board. The JH Air budget was amended by the BCC on August 29<sup>th</sup>, 2022.

A motion was made by Commissioner Barron and seconded by Commissioner Propst to approve the contract for service pursuant to the adopted FY2023 budget appropriations for Jackson Hole air as presented. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

3. Consideration of Proposed Outgoing Commissioner Correspondence

A motion was made by Commissioner Propst and seconded by Commissioner Barron to approve the letter dated September 19, 2022, as presented. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

4. Consideration of BUILD Paper Grant Agreement

A Grant Agreement under the FY2020 BUILD Transportation Grants Program. Teton County, serving as the applicant/recipient and representing seven entities in western Wyoming and eastern Idaho, has been selected for a FY2020 BUILD Transportation Discretionary Grant in the amount of \$25,000,000 for the Teton Mobility Corridor Improvements (TMCI) project. The TMCI will implement a series of thirteen multimodal improvements along the ID-33/WY-22 corridor between Driggs, ID and Jackson, WY, connecting residents and visitors to many of the region's economic generators, including Grand Targhee Resort, City of Driggs, City of Victor, Jackson Hole Mountain Resort, and the Town of Jackson.

Public comment was given by Jared Smith and Tim Young.

A motion was made by Commissioner Propst and seconded by Commissioner Newcomb to approve the Grant Agreement under the Fiscal Year 2020 BUILD Transportation Grants Program with the United States Department of Transportation for \$25,000,000. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.
