October 3, 2022

JACKSON, WYOMING

The Jackson Town Council met in conjunction with the Teton County Commission in a joint information meeting (JIM) located in the County Commissioner's Chambers located at 200 S. Willow St. at 1:31 P.M.

I. ROLL CALL. Upon roll call the following were present:

IV. CONSENT CALENDAR.

A. Meeting Minutes. To approve the meeting minutes for the September 12, 2022 meeting as presented.

On behalf of the County, a motion was made by Commissioner Propst and seconded by Commissioner Epstein to approve the minutes from September 12th, 2022. Chairwoman Macker called for a vote. The vote showed four in favor and the motion carried 4-0 for the County.

The Town requested a continuance of approval the minutes to accommodate more time for review.

On behalf of the Town, a motion was made by Councilmember Chambers and seconded by Councilmember Jorgensen to continue approval of the September 21, 2022 Joint Information Meeting to the November JIM. Vice-Mayor Jorgensen called for a vote. The vote showed five in favor and the motion carried 5-0 for the Town.

V. MATTERS FOR DISCUSSION

A. A. Regional Transportation Governance Discussion

Charlotte Frei, Regional Transportation Planning Administrator, presented a slideshow and led a discussion on regional transportation governance.

This item was brought before the Council and Commission to direct the Regional Transportation Planning Administrator to take initial steps toward regional transportation governance. Three questions are posed for consideration at this meeting:

1. Are the four high-level goals for Phase 1 acceptable
2. What general form should regional governance take
3. Who should be involved in Phase 1 (2023-2024)

Public comment was given by Tim Young, Jared Smith, Lizann Eisen, and Melissa Turley.

Councilwoman Chambers left the meeting at 4:02 P.M.

On behalf of the County, a motion was made by Commissioner Propst and seconded by Commissioner to

to direct staff to convene a Regional Transportation Task Force comprised of those listed in Table 2, as amended to include Teton Village Association and START, for the calendar year 2023 that will accomplish the below and regularly report back to the Council and Commission on its progress:

1. Identify, study, and provide recommendations for developing regional transportation plans in general accordance with state and federal regulations and policies;
2. Build regional partnerships with neighboring counties, WYDOT, relevant Federal agencies, and community stakeholders;
3. Develop a recommended outline of a JPA;
4. Identify the structure for partnerships with other entities, including their role in the decision-making process, and develop a recommended outline of necessary agreements with those entities; and
5. Establish initial procedures to ensure general compliance with state and federal regulations and coordination across Town and County departments.
6. Convene a citizens' advisory committee composed of organizations including but not limited to existing Joint Powers Boards, Resort Districts, and NGOs in task force discussions.

Chairwoman Macker called for the vote. The vote showed four in favor and the motion carried 4-0 for the County.
