May 16, 2019

- I. **Call to Order** – Rich Ochs called the meeting to order at 8:30 AM
- II. **Around the Room Introductions** – Introduced all organizations and participants.
- III. **Approval of March LEPC Meeting Minutes** – Tom Ninnemann made a motion to approve the March LEPC Meeting Minutes. Michelle Weber seconded the motion. All approved.
- IV. **Tier II Review** – Rich Ochs showed everyone the Peac Web Tool on the Tier II Reports. Aristatek is the vendor the state retained for this service. Peac Web shows all the hazardous material facilities. It maps out the worst-case scenarios for each facility and wind direction for evacuations. Contact Rich Ochs for a log-in and password.
- V. **Mitigation Plan Update** – Ryan Carrol presented the Wyoming Region 8 Hazard Mitigation Plan. He reviewed the agenda. We are in phase 3, developing a mitigation strategy/risk assessment phase and writing the plan. Most hazard mitigation plans include mitigation, preparedness, response and recovery. We are mostly looking at prevention. Received 217 Survey #2 results. Reviewed results of the survey including human, Infrastructure, environmental, mitigation goals, key themes, top strategy goals, community preparedness results, specific action approaches and citizen priorities.
 - a. **Flooding** - Reviewed risk assessments and hazard profiles on flooding (areas, homes, bridges, etc.). Consider flood insurance, stormwater systems, education, awareness, planning & development.
 - b. **Hail** - Reviewed risk and vulnerability on hail. Reviewed mitigation actions to consider.
 - c. **Lightning** - Reviewed Hazard data, risk & vulnerability and mitigation actions to consider on lightning.
 - d. **Winter Storm** – Reviewed hazard data, risk & vulnerability and mitigation actions to consider during winter storms.

Moving forward we will review remaining hazards including wildfire, landslides etc. on June 14th. Draft plan review will be in July and then submit to FEMA.

- VI. **Around the Room** – Media - CBS national news is on KJAX. KSGT will have a Spanish translation. Still working on EAS system. Saturday is Elk Fest. Airport had a tabletop last month. Will send an AAR. May 29th will do a joint training with JH Fire/EMS. There is construction on the parking lot. Will start paving soon. This will add additional spaces and should be completed by July 1st. Just completed 100-year storm improvement. Next week generators will be on all airport owned facilities. Park is just starting to monitor flooding. Pacific creek is at action stage. chip sealing will begin today from south to north. Health Department – ICS 400 training is May 21 and 22. Public information officer class is May 29 & 30, G291 joint information class is May 31. Check with your health care provider to see if you received the measles vaccination. There was a case of the mumps over spring break. Bats tend to come out in the summer. Hospital is adding additional training. Ramping up for summer. Repaving parking lots. The living center is projected to be 18 to 24 months. WYDOT has been fortunate with mudslides and cooler nights. Geology will be looking at Twin Pines in the canyon. There will be a lot of paving this summer. Be aware there is still a lot of snow in the high country. Cattleman’s bridge is complete. Town of Jackson appreciates everyone’s comments and adding the commuters and guest consideration. Town is working on the new budget. Looking at getting the plans to the public. EOC – NOAA emergency alert system has been down for three weeks. EAS encoder is being repaired. IPAWS generates alerts over the internet. Would probably initiate the wireless alert on your cell phone if needed.
